

## B-1 Blind Installation Instructions

Note: This is best done with the stand on the ground.

STEP 1: When using with L-200 and L 220 double stands attach to stand with the brackets provided as seen in ( Figure 1) and when using on L-100 and L-110 single stands position clamp as in( Figure 2)

Now the blind should be in position as seen in ( Figure 3)

STEP 2: Now open rear window and secure strap around tree to hold the blind to tree as seen in (Figure 4)

STEP 5: Now you can pull the blind down and position on the stand as seen in (Figure 5 and 6)

STEP 6: Pull the rear panel around the back of stand and snap the four snaps as seen in (Figure 7)

STEP 7: Now look inside the blind and tie all the strings to their corresponding tubes as seen in (Figure 8) You may have to position the shooting rail to match the seam in the blind.
