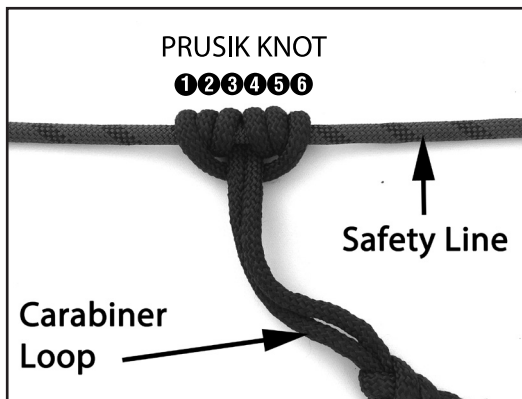

BEFORE USING THE PRUSIK KNOT, PLEASE INSPECT IT AND ENSURE THAT IT LOOKS LIKE THE PHOTO BELOW. FOR THE PRUSIK KNOT TO FUNCTION CORRECTLY, THERE MUST BE SIX LOOPS MADE AROUND THE SAFETY LINE AS SHOWN IN THE PHOTO BELOW.

Warning: Always inspect and test the Prusik knot prior to using the SafeLink. To test, grip the rope slightly above the knot with one hand while pulling sharply on the carabiner. Be certain to check that the knot securely tightens around the SafeLink rope. If you are uncertain that the knot is functioning properly, or if you have any question about the condition of the rope or knot, DO NOT USE THIS PRODUCT. DANGER: This product is designed to arrest a fall while climbing to, and descending from, your tree stand.

To put this product into service, you must first climb the tree without this SafeLink product in place. During installation and set-up of this product at your tree stand location, you must wear a fall arrest harness that meets or exceeds industry standards recognized by TMA and a lineman style climbing strap that has also been tested to standards recognized by TMA. For your own safety, you must be attached to the tree the entire time - from when you leave the ground until you return to the ground.

IMPORTANT: When using this product, you must be attached to it the entire time you are climbing. That means you attach before you leave the ground, and do not detach until you are once again on the ground. You will not need to attach your safety harness to any other tree strap while you are in the stand - Stay connected to the SafeLink.

- 1 Put on your Millennium Safety harness, and properly adjust according to the instructions included with the harness.
- 2 You must remain connected to the SafeLink at all times while you ascend and descend - and during the entire time you are off the ground. If you are using a hang-on style stand, or for use prior to installing the SafeLink, you need to use a lineman style climbing strap in conjunction with your safety harness.
Be sure to follow all directions and instructions for safe use of the climbing strap and harness.
- 3 Once you are in the tree stand, place the looped end of the SafeLink around the tree, and pull the entire rope through the loop (photo 1).
- 4 Let the end of the rope fall to the ground, leaving the prusik knot and carabiner near the loop. Attach the carabiner to the tether on your safety harness.
Tighten the lock lock nut on the carabiner. You are now ready to descend to the ground.
Climb down the tree, sliding the prusik knot down with you as you descend the tree.
- 5 When you are on the ground, you can disconnect from the SafeLink rope by unscrewing the lock nut on the carabiner, and disconnect from the tether point on your safety harness.
Tie-off the end of the SafeLink near the base of the tree. When tied-off, the rope should be somewhat taut. (You don't want a lot of slack in the rope when tied-off).

NOTE: When ascending or descending the tree, be sure to attach the carabiner to the tether point on your safety harness, and tighten the lock-nut to secure you to the SafeLink. (photo 2).
Be sure to slide the prusik knot along with you as you climb up, or down, the tree. Do not hold onto the prusik knot while climbing! Move it into place as you climb and then release your hand.

WARNING: Holding the Prusik knot during a fall situation can cause the SafeLink and knot to fail, causing you to fall to the ground. This situation can cause serious injury or death.

- 6 Once you are at your tree stand, and are no longer climbing, slide the prusik knot overhead where you have no slack in the rope when you are seated in the stand.
- 7 This SafeLink can be left in your tree stand location for up to 2 weeks. It is critical that you inspect the SafeLink for any damage or wear before you use it - EVERY TIME. Do not leave the SafeLink in service from year to year as it will shorten the life of the product and it will be prone to damage from wildlife, UV rays, and the elements. This potential damage can cause serious injury or death. Inspection before every use is critical to your safety.
- 8 Do not use this product for anything other than its intended use. Using this rope for towing, or pulling can reduce its effectiveness and cause injury or death to the user.
- 9 This product must be replaced every two years (from the date of manufacture or purchase). Please retain your register receipt to establish proof of purchase and date purchased.
- 10 Should you experience a fall, DO NOT GRAB THE PRUSIK KNOT! WARNING! Grabbing the Prusik Knot during a fall can cause the user to fall to the ground, causing serious injury or death. Let the prusik knot to arrest your fall.
- 11 In the event that you should fall, it is important that you stay calm. Do not panic. If your steps or ladder are still in place, use them to climb down from your stand. In the absence of steps or ladder, use your suspension relief strap to relieve the pressure on your legs in the event you have fallen.
- 12 Hanging suspended for long periods of time can cause serious injury or death as a result of blood pooling in your lower extremities. Always carry a suspension relief strap or a spare screw-in style step to help you relieve pressure from your safety harness after a fall.
- 13 Before hunting, always let someone know your location and the expected time you are to return. Always carry a mobile device, whistle, two-way radio or personal locator beacon in the event you need to call for help.
